

## **SDRME Summer Business Meeting June 27, 2010**

### **Treasurer's Report**

Nicole Borges reported that as of the start of the summer meeting in Chiago, we have balance of \$21,379.83 in our checking account. The balance in our savings account was reported to be \$18, 596.99.

### **Committee Reports**
